I, the undersigned hereby declare as follows:

1. With this indemnity form, I exempt Authentic Taekwon-Do, it's Agents, Represented Members, any member employed, or any other person of implied responsibility involved with above mentioned activity as offered by Authentic Taekwon-Do, with regards to any claims, actions, or costs caused and/or demanded from them in the case of any injuries, loss, damage, expenses or medical costs incurred by the competitor, as a result of this event.
2. I declare that I am medically fit to participate in the abovementioned event, and that I do not pose any threat or risk to myself or other competitor by participating in this event. Should any medical condition exist, this will be outlined on my registration form and will seek my doctor's advice closer to the event, to ensure my condition will not deteriorate or be negatively affected by participating in this event.
3. I am aware that I participate in this event at my own risk, and I undertake to immediately notify an official event staff member should any circumstances/conditions during the course of the competition pose a danger to my health and/or safety.
4. I furthermore exempt the parties as mentioned in paragraph 1, should any claim/action or exhortation be instituted against any such party because of action or neglect on my behalf, if such action causes damage to a third party or persons.
5. Should I make use of any equipment loaned from Authentic Taekwon-Do, I will not hold Authentic Taekwon-Do responsible for failure of said equipment resulting in injury to myself or others.
6. I authorise first-aid officers to perform first aid medical treatment on myself should it become necessary. I furthermore authorise the first aid officers to give permission to a hospital or medical doctor to perform any necessary treatment in the case of an emergency. Should any medical cost be incurred, it is and will be the responsibility of myself, as the competition participant to cover these costs.

## COMPETITOR CONTRACT

The following conditions must be read carefully:

1. **“The competitor”** means the individual who signs this contract and agrees to be bound by its terms and includes a guardian of that individual if the individual is under 18 years of age.
2. **Acceptance Guardian Acceptance (persons under 18)**

the competitor, hereby agree to be bound by the terms of this contract with Authentic Taekwon-Do and the persons named and described in **Schedule 1**, hereinafter jointly and severally referred to as **“the Providers”**. The providers agree to permit me to use their premises, equipment and facilities for competing (**“the Event”**) upon and subject to the following terms and conditions:

- a. **Competition Fees** – The competitor will have paid the prescribed or stated fees for the competition. Such fees may be notified to the competitor by letter or memorandum
- b. **Exclusion of Liability** – Except where provided or required by law and as such cannot be excluded, the competitor agrees that it is a term of this contract and where applicable also of his/her membership of Authentic Taekwon-Do that the Providers are absolved from all liability however arising from injury or damage however caused (whether fatal or otherwise) arising out his/her involvement and/or undertaking the event.
- c. **Release & Indemnity** – In consideration of Authentic Taekwon-Do accepting the competitor as an entrant for the event
  - i. releases and forever discharges Authentic Taekwon-Do from all Claims that s/he may have or may have had but for this release arising from or in connection with his/her membership of Authentic Taekwon-Do and or undertaking the Event; and
  - ii. indemnifies, will keep indemnified and hold harmless Authentic Taekwon-Do to the extent permitted by law in respect of any Claim by any person including but not only Members of Authentic Taekwon-Do arising as a result of or in connection with his/her membership and/or undertaking the Event.
  - iii. In this clause “Claims” means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising but does not include a claim in respect of any action, suit, etc made by any person entitled to make a claim under a relevant Authentic Taekwon-Do insurance policy.
- d. **Insurance** – The competitor acknowledges and agrees that the fees for the Event do not include personal injury insurance. The competitor can, in his/her own interests, seek and obtain personal injury insurance.

- e. **Medical Conditions** – The competitor warrants that s/he
  - i. is and must continue to be medically and physically fit and able to undertake the Event,
  - ii. is not a danger to him/herself or to the health and safety of others,
  - iii. has not at any time suffered any blackout, seizure, convulsion, fainting or dizzy spells and
  - iv. is not presently receiving treatment for any condition, illness, disorder or injury which would render it unsafe for the competitor to take part in Martial Arts undertaking the Event.
- f. **Inherent Physical Contact** – The competitor acknowledges and accepts that close physical contact with other competitors is inherent in the Event. The competitor accepts such close physical contact is necessary to undertake the Event.
- g. **Exclusion of Applicant** – The competitor warrants that he or she has not at any time been excluded from Contact Sports by a medical practitioner or any person or entity including competition officials and its constituent Area Councils and Clubs. The competitor acknowledges and agrees that the Providers may demand a medical certificate or opinion as to the fitness of the competitor from a qualified medical practitioner PRIOR to the competitor undertaking the Event.
- h. **Rights of a Consumer** – The Event is a “recreational service” as defined under the *Trade Practices Act 1974*. Where the competitor is a consumer, as defined by any relevant law such as the *Trade Practices Act 1974* or any *Fair Trading Act*, then certain terms and rights will be implied into the contract for the supply of the Service for the benefit of the competitor. These terms and rights, and any liability of the Providers or other supplier flowing from them, are excluded, restricted or modified by the provisions of this contract.
- i. **Wavier and Indemnity** – In all other cases and except where inconsistent with the above, the competitor for him/herself, his/her executors, administrators, dependents and other personal representatives, hereby absolves and indemnifies and will keep indemnified the Providers and all their servants, agents, employees and other students or persons under the Providers’ control (**the “Indemnified”**) from all liability howsoever arising for injury or damage (including but not limited to the competitor’s person, whether fatal or otherwise, property and personal belongings) however caused including by the negligence of the indemnified, arising out of or participating in Martial Arts. Or any activity carried on by the indemnified including the provision of the Event.
- j. **Competing done at Competitor’s own Risk** – Any person competing, intending to compete coaching or participating in any activity carried on by Authentic Taekwon-do may only do so on the distinct understanding that they do so entirely at their own risk.
- k. **Acceptance** – Performance of the Providers’ obligations under the contract may be effected by any one or more of the providers either jointly or severally.
- l. **Bar to proceedings** – The Providers may plead this contract as a bar to proceedings now or in the future commenced by or on behalf of the competitor or by any person claiming through the competitor.
- m. **Statement of Understanding** – I, the competitor have read, or have had read to me the above conditions and having understood the same, I consent to the activities proposed.
- n. **Entire agreement** – This agreement (and the documents to which it refers) constitutes the entire agreement between the parties in respect to the Event and supersedes all other agreements, understandings and representations and negotiations with the Event.
- o. **Warning – Contact Sports are inherently dangerous.** Serious accidents can & do happen which may result in the competitor suffering injury to person and/or property or being killed. The competitor has voluntarily read and understood this Warning and accepts and assumes the inherent risks in competing.
